1 Briefly describe the organization's mission: We seek to improve the lives of companion animals and to solve the problem of pet overpopulation in the Espanola Valley by providing humane shelter for cats and dogs, facilitating their adoption and offering spay-neuter, humane education, and other progressive animal welfare programs.

4a (Code:) (Expenses \$ 708,729 including grants of \$) (Revenue \$ 257,523) Shelter - EVHS serves approximately 43,000 people in Northern New Mexico. In 2014, we received 3,215 animals, which roughly equates to one unwanted animal per five households. Comparing this to intake rates for nearby cities indicates how much of an animal overpopulation problem we face. Los Alamos, a community just 40 miles away, has a rate of one animal surrendered per sixty households annually. Nearby Santa Fe has an estimated rate of one to ten. We are an open-admission animal shelter that cares for every animal, regardless of how old, sick, neglected or abused. We do not impose surrender fees because neglected animals need a refuge from people who have no resources to care for them. If we only accepted highly adoptable pets or pets with surrender fees, the animals turned away would be at risk of being homeless, unwanted, and producing additional litters of homeless animals.

4b (Code:) (Expenses \$ 462,968 including grants of \$) (Revenue \$ 49,415) Clinic - We operate a high-volume spay/neuter clinic that has resulted in a steady decline of animals at the shelter. In 2005 the shelter took in 4,480 animals and last year we received 3,215 animals, many of which were already spayed/neutered. Given the widespread poverty, surgeries and vaccinations are free for the pets of area residents. In 2015 we completed 4,140 surgeries, performing an average of 21 surgeries per day. The Pet Amigos is a community engagement program that looks for creative ways to reach people in need of animal care services. Our Pet Amigos team went door to door telling residents about our services. We also were present at community events and festivals; in many cases, we transported animals to and from our clinic for surgery. We found that initially only about 20 percent of the pets in the houses contacted were spayed or neutered. However, when Pet Amigos takes information and services to residents, we are able to ensure that around 70 percent of these unaltered pets were fixed.

4c (Code:) (Expenses \$ 400,189 including grants of \$) (Revenue \$ 0) Thrift Stores - We operate two consignment stores in Santa Fe to support our mission, either by finding unusual, high-quality collectibles or by earning tax-deductions for donated items. The Barkin' Boutique features designer and high-quality clothing, distinct collectibles, fine jewelry, shoes, purses, accessories, and original art. We also have adorable kitten and cats up for adoption that customers can visit while browsing our merchandise. The Barkin'Attic specializing in exceptional consigned furniture, period antiques, mid-century modern, ethnic textiles, rugs, lighting, pottery and art.
